

PROPOSED CONSTITUTION RULE CHANGES

CURRENT

Section 2.Dues:

- a) The annual dues for Active members, as established in 2016, shall be \$293.20. Fifty Dollars (\$50.00) of this amount shall be placed in a capital improvements account. Dues are payable on the first day of January each year.
- b) The annual dues for Social members, as established in 2016, shall be \$81.44.
- c) The annual dues for Provisional members, as established in 2016, shall be \$151.49. Fifteen dollars (\$15.00) of this amount shall be placed in a capital improvements account. At the time that a Provisional member becomes an Active member, the dues paid under this subsection shall be prorated to credit the dues owed under Section 2(a).

PROPOSED:

Section 2 - Dues

- a. The annual dues for Active members, as established in **2024**, **shall be \$350.00**. Fifty Dollars (\$50.00) of this amount shall be placed in a capital improvements account. Dues are payable on the first day of January each year.
- b. The annual dues for Social members, as established in 2024, shall be \$100.00.

c.The annual dues for Provisional members, as established in **2024**, **shall be \$180**. Fifteen dollars (\$15.00) of this amount shall be placed in a capital improvements account. At the time that a Provisional member becomes an Active member, the dues paid under this subsection shall be prorated to credit the dues owed under Section 2(a).

d. The rates listed under sections 2 (a, b, & c) above will increase by 3% per year starting in 2026.

SPECIAL ANNOUNCEMENTS - CONTINUED

PROPOSED CONSTITUTION RULE CHANGES

CURRENT:

Section 3. Entertainment Coupons: Annually, each Active and Provisional member of Bay View Yacht Club shall be obligated to purchase credits on their membership card worth one hundred dollars (\$100.00). These credits may be used for the purchase of Bay View Yacht Club goods and services to include, but not be limited to, the Commodore's Ball, Bay View Yacht Club approved parties, homecoming, Bay View Yacht Auxiliary, drinks and food from Bay View Yacht Club bar or tickets to Blue and Satin Gavel functions.

The credits are not to be accepted for payment of dues, special assessments, gasoline, dock fees, including electrical, storage fees, or any fines that may be assessed by the Dock or Yard committees or the Board of Trustees of Bay View Yacht Club.

The card credits may be used only in the year for which purchased. The credits shall be valid from February 1st through January 31st of the following year. (No refunds will be given for unused credits.).

New Provisional members shall be obligated to purchase membership card credits for the remainder of the year, prorated to include the quarter of induction. Active and Provisional members whose memberships terminate in mid-year shall be entitled to receive a refund for unused credits for the remainder of the year, prorated to include the quarter following termination. Denomination of the membership card credits shall be One Dollar (\$1.00). Cash less than One Dollar (\$1.00) is to be given as change for the credits. Failure to pay the membership card credit fee will result in the member being delinquent under Article XV, Section 1.

Proposed:

Section 3. Entertainment *Credits*: Annually, each Active and Provisional member of Bay View Yacht Club shall be obligated to purchase credits on their membership card worth one hundred dollars (\$100.00), *Social members shall be obligated to purchase credits on their membership card worth fifty dollars* (\$50.00)

These credits may be used for the purchase of Bay View Yacht Club goods and services to include, but not be limited to, the Commodore's Ball, Bay View Yacht Club approved parties, homecoming, Bay View Yacht Auxiliary, drinks and food from Bay View Yacht Club bar or tickets to Blue and Satin Gavel functions.

The credits are not to be accepted for payment of dues, special assessments, gasoline, dock fees, including electrical, storage fees, or any fines that may be assessed by the Dock or Yard committees or the Board of Trustees of Bay View Yacht Club.

The card credits may be used only in the year for which purchased. The credits shall be valid from February 1st through January 31st of the following year. (No refunds will be given for unused credits.).

New Provisional members shall be obligated to purchase membership card credits for the remainder of the year, prorated to include the quarter of induction. Active and Provisional members whose memberships terminate in mid-year shall be entitled to receive a refund for unused credits for the remainder of the year, prorated to include the quarter following termination. Denomination of the membership card credits shall be One Dollar (\$1.00). Cash less than One Dollar (\$1.00) is to be given as change for the credits. Failure to pay the membership card credit fee will result in the member being delinquent under Article XV, Section 1.




