We had a small team that worked tirelessly to pull off an amazing room and.....WE WON FIRST PLACE!!! We just wanted to take time to share the news and thank those that helped us this year.

## **From the Dock repair and Welding committee.**

This is a reminder to all dock holders to look at their docks and communicate any need of repair to the dock repair and welding committee.

There is a black binder located behind the bar labeled "Dock Repair & Welding Forms", before filling out the form please read the instructions in the front of the binder as well as the instructions on the request form before submitting it. These forms will be collected and all repairs addressed no matter how long it takes (Weather and Water levels permitting). The Black binder will be available until the barge is launched, the binder will then be removed from the bar and no other requests will be considered! The barge will be launched around April 4<sup>th</sup> 2020 or later, weather dependent. Take a proactive roll and fill out your repair form as early as possible to avoid not having your dock repaired. The welding committee will continue welding on cleats and pole brackets that are provided by the dock holder, but the club will provide two cleats for each dock, they will be located on the shore or main dock side of the dock. As a side note; due to safety reasons there will be no welding done on docks with a boat in the dock well, the boat must be moved. In addition, any emergency welding repairs of docks or broken equipment that occurs during the boating season can be repaired by contacting the welding chairman Jay Kelley.

A note regarding BVYC invoice questions; when a member has a question or concern regarding his/her invoice please direct your communication to the appropriate committee chairman: Dock Assignment – P/C Steve Suffety; Yard – P/C Colleen Cashman (Mike DeAngelo); Work Hours – Nate Edmunds. Their contact information is contained in the committee list, which is posted on the bulletin board in the Anchor Room and on the Members Only section of [bvyc.org](http://bvyc.org). Financial Secretary Trimmer prepares invoices with the information provided by the chairman; she will not be able to answer the questions. With this in mind, you will soon receive your 2020 dock invoice. Regarding dock electrical charges, please read the article by P/C Rob Pawloski in this edition of the Bay Views.

Bay View Yacht Club Work Plan: We recently had members who believed they had met their work hour obligation for the second half of 2019, only to learn that they hadn't when their name appeared on the Delinquent List. Process: when a member completes a work assignment he/she must fill out a Work Hour Slip, have the appropriate committee chairman sign it, and insert the white copy in the white mail box labeled “Work Hours”, which is mounted to the right of the bulletin board in the Anchor Room. Retain your yellow copy as proof that you did the work. What happens to the white copy? The Timekeeper collects them, maintains a record of the hours completed by each member, and prepares a report of members with unworked hours for the Board of Trustees for review in July and January. The Board reviews the hours, possibly makes some revisions, and provides a list to the Financial Secretary for invoicing. Please ensure that your work slips are put into the correct mail box.

## **Proposed Rule Change Dock and Harbor rule #26**

### **Currently reads:**

#### **26. Electrical charge schedule:**

a) Minimum service (light and battery charger) \$15.00 season b) TV or small appliances \$20.00 season c) Refrigerator and cooking appliance \$50.00 season d) Air conditioners - each unit additional \$35.00 season e) Electric heater \$15.00 season f) Living aboard-is defined as three nights per week, excluding holidays \$10.00 per week \$35.00 per month

### **Change to read**

#### **26. Electrical charge schedule**

All dock holders will be billed for only 1 (a, b, or c). Air conditioners and heaters are billed as extras. Reverse cycle air conditioners will be billed for air and heater

- a) Minimum service for small boats (dock light and battery charger) \$15.00 for the season
- b) Boats having TV or small appliances (coffee pot, toaster, microwave) \$20.00 for the season
- c) Refrigerator, cooking appliances (Built in stove or oven) and hot water heater \$50.00 for the season  
Second refrigerator an additional \$50.00.
- d) Air conditioners-each unit an additional \$35.00 for the season.
- e) Electrical heater or reverse cycle air \$15.00 each unit for the season.
- f) stand-alone Ice makers-each unit \$20.00 for the season.
- g) Living aboard- is defined as three nights per week, excluding holidays \$10.00 per week and \$35.00 per month.

This rule change was passed at the March 11 regular meeting. The dock committee has the authority to review and to request new dock cards or inspect the boats so they may submit correct billing information to the Financial Secretary. All discrepancies in dock and dock electrical billing must be directed to the Dock Committee for resolve.

### **Some examples:**

Someone having a (small speed boat. Day sailor sailboat. Fishing boat) usually not having a shore cord connected will be billed for a) only at \$15.00 for the season. This charge was intended to cover the cost for the light at the front of the dock, an occasional lead cord for a battery charger or electric hand tools to perform work on the boat.

Someone having a smaller boat with cuddy cabins who occasionally spends the night which may carry a (coffee pot, toaster or even a TV on board) and usually have a shore cord connected will be billed for b) only at \$20.00 for the season.

Midsized to larger cruiser boats where shore power cords are almost always connected who have a (refrigerator or stove or hot water heater) on board and occasionally spend weekends on board will be billed for c) only at \$50.00 for the season but if said boat has a second refrigerator on board an additional fee of \$50.00 will be added.

For any boats having Air conditioners, reverse cycle Air conditioners, small space heaters or Ice makers on board shall be billed accordingly per (d,e,f) in addition to (a,b or c). Reverse cycle Air are essentially \$35.00 plus \$15.00 or \$50.00 each unit per season

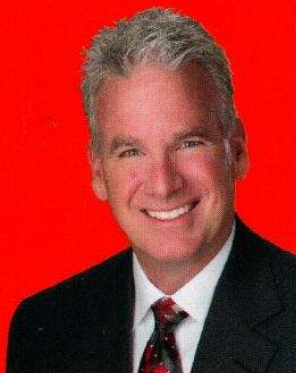
