Board of Trustees

Our bar and galley remain closed due to the COVID-19 pandemic, as directed by Ohio Governor Mike DeWine. At the approval of the Board, security cameras have been installed in the club to monitor exterior doors, the main gate, the basement sump pump, and the bar area. The daily cleaning service and regular trash pick-up have been suspended. Coolers, refrigerators, and ice makers have been emptied, cleaned, and turned off to reduce electricity cost.

The Boat Yard will be launching boats, operating within the provision of the Stay at Home Order that designates a marina as an essential business. Additional, temporary Yard rules have been approved by the Board and posted at the Yard entry gate. These rules are solely for the protection of our members. The rules are available on bvyc.org, Members Only page and in the Haul-Out Shed

On a positive note, the Gas Dock upgrades have been completed, which include new piping, risers, valves, break-away connectors, hoses, and nozzles; an Emergency Stop switch near the door to the Gas Dock House and a new tank measuring probe in Tank #1.

As we look forward to the coming boating season it is imperative that we continue to follow the COVID-19 guidelines provided by our elected officials to help keep each other safe.

BVYC History Moment

Recently the Club has refurbished and reframed the Past Commodores pictures that adorn the wall coming in from the main entrance. I found the beginnings of this tradition in some old club meeting records. The following is copied from the minutes of the August 8, 1912 weekly meeting of the Toledo Power Boat Club:

The foallowing resolution was offered and ordered spread upon the minutes:

resolved: that it is with sincere regret that we learn of the decease of Commodore Frank M. Underwood. Commodore Underwood was the leading spirit in the organization of The Toledo Power Boat Club, and was one of the incorporators and charter members of the club. He was also our first Commodore; being elected June 15, 1905; he was again elected March 7, 1906; and again Nov. 4, 1910. He was always loyal to The Toledo Power Boat Club, procuring more new members than any other three members combined. He was kind hearted, always willing to help a brother boatman, who was in need of assistance, and worked hard to enable his friend to enjoy the pleasure of his boat. *He died Tuesday, Aug. 6th, 1912, aged 58 years.*


It is recommended that the above resolution be spread upon the records of the club, and that the club procure a suitable picture of the late Commodore and have it framed and placed in the club rooms.

This meeting occurred three months after the new club house was officially opened on May 10, 1912.


